

Terms and Conditions

S\$100 shopping vouchers and gift with S\$1,000 spend or more

- 1. Marina Bay Sands Pte Ltd (the "**Organiser**" or "**MBS**") is the organiser of this Promotion, as described in paragraph 3 herein ("**Promotion**"). Conditions contained herein, including information on how to participate in the Promotion and the Voucher details, apply to the Promotion. By participating in the Promotion, the participant agreed to accept these Conditions.
- 2. The Promotion Period is from 13 November 2015 until 10:59pm on 31 December 2015 ("Promotion Period").
- 3. During the Promotion Period, the first 60 participants meeting the following requirements each day shall have the opportunity to redeem one S\$100 Shopping Voucher, which may be used at participating outlets and establishments within The Shoppes at Marina Bay Sands ("The Shoppes"):
 - a. A minimum spend of S\$1,000 ("Spend") at participating stores located in The Shoppes at Marina Bay Sands, the ArtScience Museum, Theatre, Sampan Ride, Banyan Tree Spa, Sands SkyPark and all participating restaurants & bars located in Marina Bay Sands. The Spend may be accumulated via a maximum of five (5) same-day transactions with accompanying valid and original receipts
 - b. The participant may not have previously redeemed the Shopping Voucher on the same day
 - c. The Shopping Voucher may only be redeemed on the date of the relevant receipts utilised for redemption. Receipts not redeemed on the day of purchase cannot be redeemed at a later date or combined with receipt(s) of a later date.
- 4. During the Promotion Period, each participant who is eligible to redeem the Shopping Voucher may also receive a Gift Voucher to be redeemed at a store within The Shoppes, subject to the following conditions:
 - a. The participant is a member of MBS' Sands Rewards Lifestyle programme
 - b. The participant may not have previously redeemed the Gift Voucher on the same day
- 5. The Shopping Voucher and the Gift Voucher may be redeemed at the redemption counter (**B2 South Promenade, near Zara**) upon presentation of the participant's (a) NRIC/passport (b) original receipt(s) from participating outlets and (c) for the Gift Voucher, Sands Rewards Lifestyle membership card. Participants who are not members of the Sands Rewards Lifestyle programme may sign up for membership at the redemption counter.
- 6. The Gift Voucher must be presented at the specific store within The Shoppes as stated on the Gift Voucher, within the store opening hours, for redemption of the gift. The gifts may not be exchanged for other items within the store, cash or store credit. Any disputes or issues in relation to the gift shall be settled between the participant and the relevant store without the involvement of MBS. Other terms as stated on the Gift Voucher shall apply.
- 7. Valid original receipts are accepted from all participating stores located in The Shoppes at Marina Bay Sands, the ArtScience Museum, Theatres, Sampan Ride, Banyan Tree Spa, Sands SkyPark and all restaurants & bars located in Marina Bay Sands.
- 8. The following transactions are not eligible for this Promotion:
 - a. Casino and hotel room transactions;
 - b. Bill payments, instalment plan payments, and voucher and/or gift certificate purchases
- 9. MBS reserves the right to disqualify any participant that does not meet the Conditions of the Promotion. These include entries submitted with invalid receipt(s) or incomplete or incorrect information. MBS is not responsible for the loss of opportunity to participate if for any reason whatsoever a participant is unable to comply with the Terms and Conditions of this Promotion.



- 10. MBS is neither responsible nor liable for any delayed, lost, stolen, incomplete, late or misdirected entries and submissions caused by any reason whatsoever. In particular, MBS is not responsible for (a) electronic transmission errors or delays resulting in an inability to participate or other loss, (b) theft or destruction of or unauthorised access to or alterations of entry materials, or for technical, hardware, software failures of any kind, (c) lost or unavailable connections, or delayed computer transmissions, whether caused by Marina Bay Sands, users, or by any of the equipment or programming associated with or utilised in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent an participant's ability to take part in the Promotion.
- 11. Vouchers are only valid for use at participating stores in the Mall. All other general terms and conditions for Voucher usage will apply. All Vouchers and gifts are non-transferrable, non-exchangeable, non-cashable and subject to availability on a first-come-first-serve basis.
- 12. At any time and without prior notice, MBS may amend these Conditions, postpone, temporarily halt or terminate the Promotion, or adjust the gift type and distribution at its sole and absolute discretion and all participants shall be bound by such amendments.
- 13. The Promotion is not open to employees of (a) tenants of the Mall or (b) Organizer.
- 14. By participating in the Promotion and/or accepting the gift or Voucher, each participant agrees that:
 - a. no claim relating to such losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents from any and all losses, damages, rights, claims and actions of any kind resulting from the Promotion and acceptance of any gift and/or Voucher, including without limitation, personal injuries, death and property damage.
 - b. consents to the collection, use and disclosure to third party service providers by MBS, of any personal data provided by a participant to MBS in conjunction with the Promotion, for such purposes as MBS deems reasonably necessary for the administration and management of the Promotion.
- 15. By participating in the Promotion, participants consent to MBS' use of their name(s), photograph(s), or any likeness of them for feedback, promotional, advertising, marketing and/or publicity purposes as MBS deems fit without any other fee or other form of compensation.
- 16. Each participant agrees to release, discharge, indemnify and hold harmless MBS and its agencies, affiliated companies, authorised partners, sub-contractors and their respective officers, directors, employees, agents from and against any claims, losses, liabilities, expenses, costs and damages arising from and in connection with participant's participation in this Promotion and the acceptance and use of the Voucher and/or Gift. MBS makes no warranties, representations or guarantee either expressed or implied regarding any Gift and/or item purchased using the Voucher, including but not limited to any warranty of merchantability and fitness for a particular purpose. Any dispute about the quality, condition or performance of the gifts is to be resolved directly between the applicant and the relevant merchant. The merchants supplying the gifts are not a participant in or sponsor of the promotion.
- 17. The Promotion Terms and Conditions are to be read in conjunction with the Terms and Conditions of Sands Rewards LifeStyle Programme ("Other Terms"). In the event of any inconsistency between these terms and the Other Terms, these terms prevail only to the extent of such inconsistency. Participants agree to this Promotion's Terms and Conditions as well as the Other Terms. Participants who fail to comply with any of the Terms and Conditions may be disqualified



from participating in the Promotion.

- 18. In the event of any dispute, the decision of MBS is final and binding and no correspondence will be entertained.
- 19. A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Terms and Conditions.
- 20. These Terms and Conditions shall be governed under Singapore law.
- 21. The Chinese version of the Terms and Conditions are only provided for reference. In the event of conflict between the Chinese and English version of the Terms and Conditions, the English version shall prevail.
