### TERMS AND CONDITIONS

- 1. Terms. The terms and conditions hereunder ("General T&Cs") and any other applicable specific terms and conditions relevant to this Promotion ("Other T&Cs") which can be accessed here: <a href="https://www.marinabaysands.com/sands-lifestyle/terms-and-conditions.html">https://www.marinabaysands.com/sands-lifestyle/terms-and-conditions.html</a>, together with any amendments as may be made from time to time, shall form a legal agreement between Marina Bay Sands Pte.
