

Terms and Conditions

Gift and S\$100 shopping vouchers with S\$1,500 spend or more

- 1. Marina Bay Sands Pte Ltd (the "**Organiser**" or "**MBS**") is the organiser of this Promotion, as described in paragraphs 3 and 4 below ("**Promotion**"). Terms and Conditions contained herein, including information on how to participate in the Promotion and the Voucher details, apply to the Promotion. By participating in the Promotion, the participant agreed to accept these Terms and Conditions.
- 2. The Promotion Period is from 10.30am on 15 June 2016 until 10:59pm on 19 June 2016 ("**Promotion Period**").
- 3. During the Promotion Period, each participant meeting the following requirements each day shall have the opportunity to redeem a gift ("**Gift**"):
 - a. A minimum spend of S\$1,500 ("Spend") at participating stores located in The Shoppes at Marina Bay Sands, the ArtScience Museum, Theatre, Sampan Ride, Banyan Tree Spa, Sands SkyPark and all participating restaurants & bars located in Marina Bay Sands. The Spend may be accumulated via a maximum of three(3) same-day transactions with accompanying valid and original receipts
 - b. The participant may not have previously redeemed the Gift on the same day
 - c. The Gift may only be redeemed on the date of the relevant receipts utilised for redemption. Receipts not redeemed on the day of purchase cannot be redeemed at a later date or combined with receipt(s) of a later date.
- 4. During the Promotion Period, each participant who is eligible to redeem the Gift and signs up for the first time as a member of the MBS Sands Rewards Lifestyle programme ("SRL Programme"), may also receive a S\$100 Shopping Voucher ("Shopping Voucher"), which may be used at participating outlets and establishments within The Shoppes at Marina Bay Sands ("The Shoppes"). The sign up must take place on the same day the participant is eligible to receive the Gift. This part of the Promotion does not apply to existing members of the SRL Programme and employees of MBS.
- 5. Applications for the MBS' Sands Rewards LifeStyle programme (SRL) must be carried out at the SRL counters within the Marina Bay Sands Integrated Resort. Only first-time applicants for the SRL membership are eligible to receive the Shopping Voucher. Applicants who have previously held SRL memberships are not eligible. Applicants must be 21 years and above. Valid government-issued photo identification (i.e. Singapore NRIC, driving license, or passport) must be presented upon application. MBS may in its discretion reject any applications for the SRL programme.
- 6. The Gift and/or Shopping Voucher may be redeemed at the redemption counter (**B2 North Promenade**, **near Skating Rink**) upon presentation of the participant's (a) NRIC/passport (b) original receipt(s) from participating outlets and (c) for the Shopping Voucher, Sands Rewards Lifestyle membership card after SRL Programme membership application procedures are cleared.
- 7. The following transactions are not eligible for this Promotion:
 - a. Casino and hotel room transactions;
 - b. Bill payments, instalment plan payments, and voucher and/or gift certificate purchases
- 8. MBS reserves the right to disqualify any participant that does not meet the Conditions of the Promotion. These include participants who submit invalid receipt(s) or incomplete or incorrect information. MBS is not responsible for the loss of opportunity to participate if for any reason whatsoever a participant is unable to comply with the Terms and Conditions of this Promotion.
- 9. MBS is neither responsible nor liable for any delayed, lost, stolen, incomplete, late or misdirected entries and submissions caused by any reason whatsoever. In particular, MBS is not responsible for (a) electronic transmission errors or delays resulting in an inability to participate or other loss, (b)



theft or destruction of or unauthorised access to or alterations of entry materials, or for technical, hardware, software failures of any kind, (c) lost or unavailable connections, or delayed computer transmissions, whether caused by Marina Bay Sands, users, or by any of the equipment or programming associated with or utilised in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent an participant's ability to take part in the Promotion.

- 10. All Gifts are subject to availability on a first-come-first-serve basis.
- 11. Shopping Vouchers are only valid for use at participating stores in the Mall. All other general terms and conditions for Voucher usage will apply. All Shopping Vouchers and Gifts are non-exchangeable, non-cashable and subject to availability on a first-come-first-serve basis.
- 12. At any time and without prior notice, MBS may amend these Conditions, postpone, temporarily halt or terminate the Promotion, or adjust the Gift type and distribution at its sole and absolute discretion and all participants shall be bound by such amendments.
- 13. Save as set out at paragraph 4 above, the Promotion is open to employees of MBS. The Promotion is not open to employees of tenants of the Mall.
- 14. By participating in the Promotion and/or accepting the Gift or Voucher, each participant:
 - a. agrees that no claim relating to such losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents from any and all losses, damages, rights, claims and actions of any kind resulting from the Promotion and acceptance of any gift and/or Shopping Voucher, including without limitation, personal injuries, death and property damage.
 - b. consents to the collection, use and disclosure to third party service providers by MBS, of any personal data provided by a participant to MBS in conjunction with the Promotion, for such purposes as MBS deems reasonably necessary for the administration and management of the Promotion.
- 15. By participating in the Promotion, participants consent to MBS' use of their name(s), photograph(s), or any likeness of them for feedback, promotional, advertising, marketing and/or publicity purposes as MBS deems fit without any other fee or other form of compensation.
- 16. Each participant agrees to release, discharge, indemnify and hold harmless MBS and its agencies, affiliated companies, authorised partners, sub-contractors and their respective officers, directors, employees, agents from and against any claims, losses, liabilities, expenses, costs and damages arising from and in connection with participant's participation in this Promotion and the acceptance and use of the Shopping Voucher and/or Gift. MBS makes no warranties, representations or guarantee either expressed or implied regarding any Gift and/or item purchased using the Shopping Voucher, including but not limited to any warranty of merchantability and fitness for a particular purpose. Any dispute about the quality, condition or performance of the gifts is to be resolved directly between the applicant and the relevant merchant. The merchants supplying the Gifts are not a participant in or sponsor of the promotion.
- 17. The Promotion Terms and Conditions are to be read in conjunction with the Terms and Conditions of the Sands Rewards LifeStyle Programme ("Other Terms"). In the event of any inconsistency between these terms and the Other Terms, these terms prevail only to the extent of such inconsistency. Participants agree to this Promotion's Terms and Conditions as well as the Other Terms. Participants who fail to comply with any of the Terms and Conditions may be disqualified from participating in the Promotion.



- 18. In the event of any dispute, the decision of MBS is final and binding and no correspondence will be entertained. Participants shall not commence any legal or other proceedings in any court or tribunal in any jurisdiction in respect of any such dispute.
- 19. A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Terms and Conditions.
- 20. These Terms and Conditions shall be governed under Singapore law.
